Rules for FEE

- 1. All the fee has to be paid strictly in advance. Fees may be paid for the whole year also.
- 2. The school fee is collected in installments of four months.
- 3. The name of the students would be struck off, whose fee is not paid by the 10th of the month when it is due. No cheques shall be accepted.
- 4. Small children should not be entrusted with the payment of fees.
- 5. No reduction is made for a broken period.
- 6. Fees should be deposited in advance latest by the 10th day of every month thereafter a fine would be charged.
- 7. Pupil will not be allowed to sit for the terminal or final examination unless all dues are paid.
- 8. Discontinuance of the bus facility will not be permitted during the session. Any fee or other charges once paid shall not refunded or adjusted.

Admission & Withdrawals

- 1. As a rule a child who is 3 years old will be admitted to the Nursery class. A corresponding age scale is fixed for the succeeding classes.
- 2. A child who joins fresh from home or from a private school has to produce the official Birth Certificate issued by the Municipal Corporation in support of the date of birth in the Admission Form.
- 3. A child who has attended any recognized school will not be admitted without a school a Leaving Certificate from the same.
- 4. Documents required for admission will not be returned.
- 5. A calender month's notice is to be given before the withdrawal of a student or a fine will be charged. Such notice should be given in written by the pupil's guardian himself. Those who leave in April must pay their fees for the month of May and June.
- 6. No School Leaving Certificate is given until all dues to the School have been paid in full.

Monday to Saturday: 9.00 a.m. to 2.00 p.m. On working days only and from 1st to 10th of each due month.
